#### SW in Kazakhstan

In the period from 15/07/2021 - 01/02/2022, a number of online meetings were attended to discuss questions on the work of the project namely:

- On September 24, 2021, an online meeting of the Consortium of participants of the project "Development of a Master program in the management of Industrial Entrepreneurship for transition countries (MIETC)" was held. The following issues were discussed during the meeting: accounting documents, in particular, a report on technical implementation, an updated work plan for the expansion of the project, accreditation of the master's program, dissemination and external evaluation, as well as the results of monitoring the project in Kazakhstan and other working issues;
- On October 22, 2021, a working online meeting of the Consortium of participants of the project "Development of a Master program in the management of Industrial Entrepreneurship for transition countries (MIETC)" was held. During the meeting, issues of internal quality assurance, external quality assurance, dissemination of project results, as well as other working issues of the administrative staff were discussed.

As a part of the MIETC project implementation on November 22-23, 2021 there was organized a meeting at Karaganda University of Kazpotrebsoyuz. The content of the new joint educational master's program of the Karaganda University of Kazpotrebsoyuz and EKTU named after D. Serikbayev "Technological Entrepreneurship" (as the main result of the MIETC project) with European partners — the University of Santiago de Compostela (Spain), the AY economics Research Center (Spain), the University of Naples Federico II (Italy) as well as with Asian partners: the Technological University of Tajikistan, the Technology and Innovation Park FANOVAR (Tajikistan), the Tajik State University of Commerce, the Pro Business Training Center and stakeholders of the Karaganda region was discssed.

On November 22, 2021 a working meeting of the project partners, University management board and stakeholders was held to discuss work packages, to share the University experience in implementing and ensuring the sustainability of previous Erasmus+ projects, a tour of the university, etc.

On November 23, 2021, an official meeting of European and Asian project members with Karaganda region stakeholders took place.

The event is aimed at deepening participants' knowledge and understanding of the role of providing participants with skills and competencies in the field of industrial entrepreneurship that meet the needs of the labor market, which is expected to raise awareness and contribute to sustainable economic development in the target regions.





The purpose of the seminar is to ensure the participation of stakeholders in the project, to discuss approaches to cooperation, joint projects, internships, etc.

Possible joint projects, cooperation and networking which can be developed to improve the cooperation between the academy and business was the main question of the seminar. Its implementation will contribute to involvement of employers in the universities' activities and educational programs development. The new Master's Program will also increase employment opportunities, encourage women's participation in the workforce and encourage companies to conduct training.

#### **Participants**

The workshop is targeted towards managers, mid-level professionals and entrepreneurs, as well as government officials responsible (25-30 people) for the development and implementation of industrial initiatives.

## Results

Main issues have been illuminated and discussed at the workshop:

- Project Management and Financial/Administrative Matters (Angel Duarte (USC);
  - Quality Assurance (Angel Duarte) (USC);
  - Distribution (Olessya Zhidkoblinova, KarUK);
- Development of the Master's program: curriculum, information materials and learning approach (Manuel Fernandez Grela, USC);
- Development of the Master's program: curriculum, information materials and training approach, the accreditation process (Olga Tyan, KarUK);
  - Entrepreneurship Centers (Hele Stavbunik, KarUK);





- Opportunities and advantages for companies (Aizhan Sambambayeva, AY economics Research Center);
- Presentation of the results of market needs (Maftuna Sodikova, AY economics Research Center);
  - Networking (stakeholders).

Different companies study cases are also learned and based on the prepared by AyEconomics questionnaire and provided information. Dr. A. Sambambayeva gave a detailed number of methods for analyzing and evaluating market demand. At the end of the workshop, the stakeholders were divided into 4 groups, round tables were set up to answer the questions within 30 minutes of their views. The roundtables were chaired by representatives of the Karaganda University of Kazpotrebsoyuz. A. Sambambayeva summed up the work of the round tables and the prepared answers and praised the training of specialists and teachers, expressing satisfaction with the answers.

The official meeting of European and Asian project members with stakeholders of the Karaganda region was held with the invitation of the Saryarga TV channel with the release of news stories on November, 23 (5.15 PM kaz.language, 5.25 PM rus. language, 7.30 PM Kaz.language, 8.30 PM Rus. language, 10.00 PM Kaz.language, 10.20 PM Rus.language, 10:00 AM Kaz. language, 10.20 ΑM Rus. language) https://kartv.kz/kz/news/society/magistrlik-bagdarlama-bolashakkakadam, https://kartv.kz/ru/news/society/arga-news-shag-v-budushchee with the provision of a news story and within the budget of the project, the translation service was organized.

As a result of the work carried out at KarUK and VKTU, the business partners of our university "Pro - Business" Training Center (introduced as participants at the expense of Erasmus+ funds) conducted a master class for the Technological and Innovation Park of Tajikistan FANOVAR with the issuance of a certificate jointly with KarUK and the University of Santiago de Compostela, which is a great joint result of the project, which was especially noted by the Coordinator of the National Office of Erasmus + in Tajikistan Nuridinova Zarina Mikhrobovna.

In the process of working, the main directions and advantages of opening an innovative joint EP were identified, an analysis of the labor market needs for certain skills and competencies of university graduates was carried out, which syllabus developers will have to provide for educational materials developing, taking into account the European experience of implementing similar EP. Therefore, in January 2022, teachers who develop and will conduct disciplines within the framework of the new





EP will take advanced training courses at universities in Slovenia, Spain and Italy, at the expense of Erasmus+.

There are also set the tasks of conducting joint research with the subsequent publication of the results in scientific rating journals as well as HAC and CCES journals. A joint ISIC is planned for April, 2022 on the online platform of our university with the invitation of project partner participants and stakeholders.











On November 30, 2021, Business Pro representatives held a master class for teachers and representatives of the Technological University of Tajikistan technopark on the topic: "Opening entrepreneurial centers in the Republic of Kazakhstan". As a result of the master class, certificates were issued to the participants.









Together with partner universities responsible for the dissemination of the project, booklets in three languages (English, Russian, Kazakh) and handouts have been prepared to inform all interested parties.

On December 22, 2021, materials for participation in the poster session of Erasmus+ projects of the postgraduate education program in Kazakhstan in three languages were prepared.

The Karaganda University of Kazpotrebsoyuz, within the framework of the training, carried out work in the field of partner universities cooperation. Two agreements were signed on joint activities within the framework of a scientific and educational consortium with the Technological University of Tajikistan and the Tajik State University of Commerce. The parties agreed to organize a scientific and educational





consortium to carry out joint scientific, educational and research activities aimed at developing a system of training highly qualified specialists and implementing research projects of theoretical, methodological and applied nature on topical issues of economics and management. A joint research theme "Social determinants of the quality and standard of living of the population: trends and events' development" was also proposed. It is planned to hold an international scientific and practical conference with partner universities in April 2022, at the moment a program of events is being developed.
