Suggestions for Improvement

The participants of the transnational meeting in Piraeus were asked to discuss with their university colleagues if they have any suggestions how to improve the common work in Complete project. Their statements are documented in the evaluation form which is available in www.infonex.eu. At this point the statements were clustered for getting a clear picture about the main issues and recommendations.

1. Suggestions regarding transnational meetings

- Feedback, concrete suggestions and expectations from partners while the agenda is in preparation. Active contribution is awaited.
- Better time management during the meetings; Time management; More effective time management; Better time management.
- Time limits for speakers should be kept; Time limit, please! Time regulation, presentations and speeches have to adhere to agreed time regulations.
- We need strict rules on timekeeping. Maybe there will be a person chosen from the group to manage the time.

- Speakers should speak up to the topic, less opinion-based boring talking (from Russia); The focus

- Clear moderation.
- I couldn't hear all the presentations because they were to quiet. In the next meeting microphone should be used; Only speakers that speak loud and clear should be asked to present; One speaker's voice was too low in spite of requests to speak louder.
- English as conference language (translated in Russian if necessary); The language of the seminar (English) seemed hard for some participants, at some point, if it is possible the summary should be done in Russian.
- It would be interesting to hear more comments from European universities.
