Moscow October 13-17, 2023

From October 13 to 17, 2023, the Vice-rector for Social Affairs A.S. Orynbekov and the leading researcher of the ELS Research Institute A.H. Fetkulov were on a business trip to Moscow in order to fulfill the calendar plan of a scientific project on the topic: "Criminal law and criminological measures to ensure safety during mining or construction work"

During the business trip, the following tasks were solved:

- collection of empirical material on the research topic and official statistics (survey and questionnaire);
- analysis of investigative and judicial practice, foreign experience in the field of countering offenses in the field of safety and labor protection;
- meeting with experts and scientists dealing with problems in the field of safety in the conduct of mining or construction work.

On October 13, 2023, they visited the educational institution of the Federal State Budgetary Educational Institution "State Academic University of Humanities". Conducted a survey of researchers and teachers on problems related to the violation of safety rules and conditions during mining and construction work, and also received advice from leading experts in the field of criminal and criminal procedure law, criminology and criminology.

Meeting with the head of the Department of Criminal Law Disciplines of the Federal State Budgetary Educational Institution "State Academic University of Humanities" Candidate of Legal Sciences, Associate Professor Sergey Smirnov. Issues of theoretical analysis and improvement of criminal and criminal procedure legislation in the field of countering criminal offenses against public safety and public order, in particular, with violations of safety rules during mining and construction work, both in the Russian Federation and the Republic of Kazakhstan, were worked out with him.







On October 13, 2023, they visited the educational institution of the All-Russian Research Institute of the Ministry of Internal Affairs of the Russian Federation, where a meeting was organized with leading specialists in the field of administrative law. In particular, with the head of the Research Center No. 4 "All-Russian Research Institute of the Ministry of Internal Affairs of Russia", Candidate of Law, Associate Professor of Police Colonel Gennady Ivanovich Kalmykov and Senior Research Associate of the Department of the Research Center No. 4 All-Russian Research Institute of the Ministry of Internal Affairs of Russia Mikhail Vasilyevich Andreyanov.

During the meeting, the issues related to the administrative legislation of the Russian Federation and the Republic of Kazakhstan, which have been undergoing a deep process of reform in recent years, were discussed. From the standpoint of scientific, theoretical and legal commentary on certain types of administrative structures of legal entities, the administrative and legal aspects of the mechanism for ensuring occupational safety and health in both countries were considered. The institute of administrative responsibility in the system of administrative and legal methods of public administration in the sphere of labor and social protection was also studied.



On October 14, 2023, they visited the Federal State Institution of Science "Institute of State and Law of the Russian Academy of Sciences" to meet with legal scholars. We also exchanged scientific literature, opinions on the topic of the study, in particular, on criminal liability for violations of the rules for ensuring working conditions and safety. A sociological survey of researchers and teachers of this educational institution was conducted to identify problems related to violations of safety rules and conditions during mining and construction work.

Meeting with Sergey Vladimirovich Malikov, Deputy Director of the Institute of State and Law of the Russian Academy of Sciences for Scientific Work, Doctor of Law. Within the framework of this meeting, problems related to the identification of promising areas of combating crime in the field of labor protection; issues of qualification of these criminal offenses; improvement of criminal legislation, investigative and judicial practice; criminological forecasting of the state, structure and dynamics of violations of labor protection rules were considered.

On October 14, 2023, they visited the Kutafin Moscow State Law University, where they received consultations from leading experts in the field of criminal law and criminology. Together with them, issues of prevention and suppression of offenses in the field of security during mining and construction work were worked out.



On October 14, 2023, they visited the Moscow Financial University under the Government of the Russian Federation (49 Leningradsky Prospekt, Moscow), where they held meetings with researchers and teachers of this educational institution to identify problems related to violations of safety rules and conditions during mining and construction work.





On October 16, 2023, in order to form a bibliographic fund on the research topic, we visited the Russian State Library, the main building, reading rooms of the Library and Information Services Department. There they extended the library cards, also worked with catalogs of specialized funds for the study of text-books on the topic of research, searched alphabetical and systematic catalogs of specialized funds of the RSL for certain types of documents, information carriers and topics on the topic of research work and carried out a selection of literature on the topic of research. The catalogs are managed by specialized departments and are located on the territory of the corresponding reading rooms of the RSL.

We worked in the reading room and the depository of candidate and doctoral dissertations on branches of legal knowledge defended in Russia. Then we visited an exhibition of new books and journals in the field of jurisprudence, worked in the department where the mandatory copies of the abstracts of dissertations of Russian scientists and scientists of the Commonwealth countries in the pre-defense period are kept. In addition, we studied: reference and information services for readers; the formation of a fund of dissertations on traditional and

electronic media on the issues of the research topic; reference fund on countering violations of safety rules during mining or construction work.

Currently, the library collection of dissertations and abstracts contains more than ten works devoted to the problems of violation of labor safety conditions and rules. The total number of works devoted to the problems of countering violations of safety rules during mining or construction work amounted to more than 60 copies of monographs, educational and practical manuals, collections of scientific papers, materials of scientific-practical and scientific-theoretical conferences, encyclopedic dictionaries on the topic of research, analytical reviews, reports, mock-ups of criminal cases, scientific articles and other scientific works.
